Presidents Report

GOC Update

1. 23d Drop Zone.

Wording in local rules to be checked to ensure Compulsory Drop is taken if ball goes in the water.

2. Single Scoring.

Single events being scored in 4-Ball events discussion resolved that members will be informed that their individual score will be recorded in Golf link when a 4-ball event is held in conjunction.

3. Christmas 2024.

8-minute intervals between groups be implemented during Christmas period.

4. Ambrose scoring.

All scores will be recorded on cards until Miscore is able to record in an appropriate way.

- 5. New Local Rules.
 - Players teeing off from the 21st tee box are not permitted to hit down the 22nd fairway. Markers will be placed to indicate Out of Bounds area.
 - All distance markers indicating 150m and 100m are to be considered immovable obstructions.
 - Players with Virtual handicaps are not permitted to play in Club Competitions unless as a guest of a member.
 - Cart owners with a medical condition who request exemption to the 10m exclusion zone around greens need to apply to the GOC for permission to drive closer to the green.

Management to establish a visible sticker for carts so that members are aware.

6. Prize allocation review.

DOG to review prize allocation to players who play Tuesday comp and pay 50c per round so prize allocation can be more equitable.

7. Charity events.

DOG and ProShop to review handicaps of previous winners of Charity events and adjust as necessary.

- 8. Action list items to communicate to members RB completion date March 2024
 - When playing 5th hole, the drop zone does not apply when playing from red or yellow tees.
 - Review handicapping system for 9-hole events.
 - Members with private carts must adhere to the 10m rule and not drive between white and green stakes.
- 9. Leader board needs to be displayed in the Sports Bar DM completion date March 2024

- The change of the working account from NAB to Westpac has been a tedious, time consuming and frustrating process, but we are nearly there. Three of us went to Westpac and I have been again to hand in the signed minutes. Now I am waiting on an email from the team at Westpac and *then* we can open the new bank account.
- Once I have the new account number, I can finish setting up the square reader to enable card payments to the account. Hopefully in the next week I am checking with Westpac every two days.
- I have changed the Chart of Accounts to reflect more detail with the Interclub expenses, but I have only had time to do the month of February, so I will continue that when I get back from Victoria.
